2. HAZARDS IDENTIFICATION SUMMARY

KEEP OUT OF REACH OF CHILDREN – WARNING - POISON – Causes irritation and corneal injury may occur. Do not get in eyes or on clothing. Harmful if swallowed, inhaled, or absorbed through skin. Avoid contact with skin. Avoid breathing spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. This product is light brown to dark brown liquid with phenolic odor.

4. FIRST AID MEASURES

If in eyes: Hold eye open and rinse slowly and gently with water 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have a person sip a glass of water if able to do so. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

5. FIRE FIGHTING MEASURES

FLASH POINT (°F/Test Method): Not established.

FLAMMABLE LIMITS (LFL & UFL): Not established.

EXTINGUISHING MEDIA: Use medium appropriate to surrounding fire. Dry chemical, carbon dioxide, foam, water spray or fog.

HAZARDOUS COMBUSTION PRODUCTS: Ammonia, oxides of nitrogen, chlorine-containing compounds and other unknown hazardous materials may be formed in a fire situation.

SPECIAL FIRE FIGHTING PROCEDURES: Wear self-contained breathing apparatus with full protective clothing. Fight fire from upwind and keep all non-essential personnel out of area of intense smoke.

6. ACCIDENTAL RELEASE MEASURES

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:

Contain spill and absorb with suitable absorbent, sweep up material and transfer to containers for possible land application according to label use or for proper disposal. Wash spill area with water containing strong detergent, absorb and sweep up as above. Check local, state and federal regulations for proper disposal.

CAUTION: Keep spills and cleaning runoff out of municipal sewers and open bodies of water.

7. HANDLING AND STORAGE

HANDLING: Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

STORAGE: Do not store below 32°F / 0°C. If frozen, warm to at least 41°F / 5°C and mix thoroughly before use. Store in a safe manner. Store in original container only. Store in a cool, dry place. Keep container tightly closed when not in use. Do not contaminate water, food or feed by storage or disposal.

Personal Protective Equipment: Applicators and other handlers must wear: long sleeved shirt and long pants, waterproof gloves, shoes plus socks, and protective eyewear. Follow manufacturer's instructions for cleaning and maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.
