**ACTAGRO 5% COPPER** is non-phytotoxic when used as directed and may be combined with most pesticides and fertilizers.

**ACTAGRO 5% COPPER** will be influenced by varieties, soil and environmental conditions and should be applied under conditions of optimum plant growth. Optimum conditions are defined as adequate humidity, moderate temperatures and adequate soil moisture. Optimum conditions for most crops generally occur during early morning or late evening hours.

### MIXING INSTRUCTIONS

**ACTAGRO 5% COPPER** disperses well in water. For best results mix as follows:

1. Partially fill tank with water or fertilizer and start agitation.
2. Add other nutrients or pesticides if compatible.
3. Add **5% COPPER** to circulating tank mix.
4. Fill tank and agitate thoroughly.
