BLAD is a naturally-occurring seed storage protein in sweet lupines; it is a 20 kDa polypeptide of  $\beta$ -conglutin, or characterized as a fragment of the amino acid sequence of  $\beta$ -conglutin.

### 4. FIRST AID MEASURES
