#### 4.1 Description of First Aid Measures

### 6.1 PERSONAL PRECAUTIONS, PROTECTIVE EQUIPMENT AND EMERGENCY PROCEDURES

Personal Precautions: Avoid inhalation of vapours and spray mist and contact with skin and eyes. Ensure adequate ventilation. Wear suitable protective clothing.

### 6.2 ENVIRONMENTAL PRECAUTIONS

Environmental Precautions: Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean highwater mark except as noted on appropriate labels. Drift and runoff from treated areas may be hazardous to aquatic organisms in water adjacent to treated areas. Do not contaminate water when disposing of equipment wash waters or rinsate.

### 6.3 METHODS AND MATERIALS FOR CONTAINMENT AND CLEAN-UP

Methods for Clean-Up: Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. After removal flush contaminated area thoroughly with water.  
Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to Remove residual contamination.  
Never return spills to original containers for re-use.

## 7. HANDLING AND STORAGE

---

### 7.1 PRECAUTIONS FOR SAFE HANDLING:

Advice on Safe Handling: Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

### 7.2 CONDITIONS FOR SAFE STORAGE:

Requirements for Storage Areas and Containers: Do not store at temperature below 0 °C.
