GRAIN-SET DIRECTIONS FOR USE

This product is only to be used to treat micronutrient deficiencies, and the user should seek the advice of an agricultural representative or a professional agricultural consultant. This product should be used on the basis of a soil an/or tissue analysis. When tank mixing with other products, compatibility testing should be conducted prior to application. Shake well before using.

PRECAUTIONS

INHALATION: Exposure may cause irritation to the nose, throat, or respiratory system. Symptoms may include coughing and shortness of breath.

SKIN CONTACT: Skin contact causes irritation. Symptoms may include redness, itching, and pain.

EYE CONTACT: Causes serious eye damage. Symptoms include redness, itching, and pain.

INGESTION: Harmful if swallowed.

FIRST-AID

INHALATION: Remove victim from source and allow to rest in a well-ventilated area. If breathing is difficult, obtain medical attention immediately.

SKIN: Remove affected clothing immediately. Flush affected area(s) with copious amounts of soap and water. If skin surface is damaged, apply a clean dressing. Wash contaminated clothing before reuse. If irritation or redness develops, seek medical attention immediately.

EYES: Flush eyes immediately with copious amounts of clean water for 15 minutes. If irritation, redness persists or allergic response exhibited, seek medical attention.

INGESTION: Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Seek medical attention.

PROTECTIVE CLOTHING AND EQUIPMENT

To minimize exposure, the following precautions should be followed. Wear impervious gloves and clothes, and chemical splash goggles or full-face shield to prevent eye contact during mixing, loading, cleanup, and repair activities. Rinse gloves with soap and water before removal and wash hands thoroughly before eating, smoking, or drinking. Clean protective equipment daily.

STORAGE AND DISPOSAL

Keep container tightly sealed when not in use. Store in a cool, dry place between 1 and 38° C. Do NOT store in direct sunlight. Do not store diluted product. Shelf life under these conditions is 24 months from the date of manufacture. Follow all governmental procedures for the disposal of the container.
