4. FIRST AID MEASURES

4.1 Description of First Aid Measures

General Advice: Get medical attention if symptoms occur.

- If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.
- If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
- If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.
- If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferable by mouth-to-mouth, if possible.

Symptoms: Causes eye irritation. Harmful if inhaled.

Treatment: Treat symptomatically. Symptoms may be delayed.

5. FIRE FIGHTING MEASURES

5.1 EXTINGUISHING MEDIA:

Suitable Extinguishing Media: May be combustible at high temperature, use medium appropriate to surrounding fire. Dry chemical, carbon dioxide (CO₂), alcohol foam, foam, water spray or fog. Do not use water jet as this will spread the fire.

5.2 SPECIAL HAZARDS ARISING FROM THE SUBSTANCE OR MIXTURE:

Specific Hazards During Firefighting: During a fire, hazardous by-products can be released and may include oxides of carbon.

Personal Precautions: Avoid inhalation of vapours, fumes, and spray mist and prolonged or repeated contact with skin and eyes. Ensure adequate ventilation. Wear suitable protective clothing.

6.2 ENVIRONMENTAL PRECAUTIONS

Environmental Precautions: Prevent further leakage or spillage if safe to do so. Do not contaminate water. Do not allow to enter drains, sewers, or watercourses.

6.3 METHODS AND MATERIALS FOR CONTAINMENT AND CLEAN-UP

Methods for Clean-Up: Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. After removal flush contaminated area thoroughly with water.
Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to Remove residual contamination.
Never return spills to original containers for re-use.

7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:

Advice on Safe Handling: Avoid inhalation of mists, vapours / spray and contact with eyes, skin and clothing. Do not breathe mists or vapour. Wear personal protective equipment. Do not use in areas without adequate ventilation. Avoid prolonged exposure. Wash thoroughly after handling. Do not empty into drains. Handle and open container with care. Use care in handling/storage. Wash before eating, drinking and/or smoking.
